

# Terms and conditions for SankalpSiksha

## 1. Who May Use our Services

The seat of Arbitration shall be at Patna. The language of the arbitration shall be English. The cost of arbitration shall be borne equally by you and SankalpSiksha &/or the Associated Parties. The award of the arbitrator shall be final and conclusive and binding upon you and SankalpSiksha & the Associated Parties.
